

REQUEST FOR PROPOSAL (RFP)

For Empanelment of Training Partners

(TPs)

Textile Sector Skill Council (TSC)

1. Introduction

The Textile Sector Skill Council (TSC), established under the aegis of the National Skill Development Corporation (NSDC) and also an Awarding Body by the National Council for Vocational Education and Training (NCVT) under the Ministry of Skill Development & Entrepreneurship (MSDE), Government of India, is the industry-led body responsible for developing the skill development ecosystem for skilling across the textile & Handloom sector.

TSC develops National Occupational Standards (NOSs), Qualification Packs (QPs), training curricula, certification systems, and quality assurance frameworks to create a globally competitive and industry-ready workforce.

To strengthen the delivery of quality skill development programmes, the Textile Sector Skill Council (TSC) invites eligible organizations to submit applications for empanelment as Training Partners (TPs) in accordance with the prevailing TSC Affiliation Norms. Empanelled Training Partners shall become eligible to be considered for participation in future TSC-led skill development initiatives. However, empanelment shall not guarantee allocation of any project, training targets, or funding, which shall be subject to the availability of projects, funding, and compliance with the applicable guidelines, eligibility criteria, and requirements of the respective project or scheme.

2. Indicative Roles and Responsibilities of Empanelled Training Partners

The following responsibilities are indicative in nature and shall apply only when an empanelled Training Partner is engaged under a specific project or scheme:

1. Candidate Mobilization

- Community awareness and mobilization
- Candidate counselling and registration
- Eligibility verification
- Mobilization of youth, artisans, weavers, SHGs, women, and other target groups

2. Training Delivery

Training Partners shall:

- Deliver NSQF-aligned training programmes
- Follow TSC-approved Qualification Packs and curriculum
- Deploy suitably qualified trainers, including TSC Certified Trainers where required under the applicable project or scheme.
- Ensure availability of machinery, equipment and consumables required as approved qualifications.
- Conduct classroom, practical, blended or workplace-based training

3. Infrastructure Management

Training Centres shall maintain:

- Classrooms
- Practical laboratories/workshops
- Textile machinery and equipment
- Adequate IT infrastructure and reliable internet connectivity.
- Safety provisions
- Drinking water and sanitation facilities

4. Assessment & Certification

- Coordinate assessments with TSC
- Prepare candidates for assessment
- Facilitate certification

5. Placement & Industry Linkages

Where applicable:

- Facilitate placements
- Promote apprenticeship
- Support entrepreneurship
- Develop linkages with textile industries

6. Monitoring & Compliance

Training Partners shall:

- Maintain digital records
- Upload candidate and training-related information on portals or digital platforms prescribed by TSC or the respective scheme.
- Submit periodic reports
- Facilitate inspections and audits
- Comply with TSC Quality Standards

3. Eligibility Criteria

Only organizations meeting the following eligibility conditions shall be considered for empanelment as Training Partners under the prevailing TSC Affiliation Norms.

A. Eligible Organizations – Textile Mill Sector Job Roles

(As per Annexure-I)

The following organizations are eligible:

- Textile Mills in running production
- Textile Mill Machinery Manufacturers, including Technical Textile Machinery Manufacturers
- State Government or Central Government recognized Textile Mill Organizations
- Registered Textile Mill Industry Associations with a minimum of three years existence
- UGC/AICTE recognized institutions offering Textile Mill programmes

B. Eligible Organizations – Handloom Sector Job Roles

(As per Annexure-II)

The following organizations are eligible:

- Registered organizations engaged in manufacturing, marketing or training of Handloom products with a minimum of three years existence

- State Government or Central Government recognized Handloom Organizations
- Registered Handloom Associations and Self Help Groups (SHGs) with a minimum of three years existence
- UGC/AICTE recognized institutions offering Textile or Handloom programmes

Mandatory Requirements

Applicants shall ensure:

- Training Partner affiliation through online application
- Availability of TSC Certified Trainers or commitment to deploy/certify trainers before commencement of training, wherever applicable.
- Adequate training infrastructure as prescribed by TSC
- Compliance with TSC Affiliation Guidelines and Quality Assurance Framework
- Compliance with applicable statutory and regulatory requirements

Important

Organizations or consultancy firms that do not satisfy the prescribed eligibility criteria shall not be considered for empanelment as Training Providers for Textile Sector Skill Council job roles.

4. Training Partner Affiliation Process

Eligible organizations shall complete the following process:

1. Submit the online application for Training Partner Affiliation.
2. Upload all prescribed documents.
3. Nominate TSC Certified Trainers for the relevant job roles.
4. Complete infrastructure verification and quality assessment, wherever applicable.
5. Receive affiliation approval from TSC after successful evaluation.

Empanelment under this RFP shall be subject to successful affiliation and continued compliance with TSC norms.

5. Evaluation & Selection

Applications shall be evaluated based on:

- Eligibility under TSC Affiliation Norms
- Organizational profile
- Infrastructure readiness
- Availability of certified trainers
- Experience in textile sector skill development
- Financial capability
- Geographic presence
- Industry partnerships
- Compliance history
- Past performance

TSC may undertake:

- Document verification
- Infrastructure Verification
- Technical Assessment (if required)
- Due diligence

The decision of TSC shall be final and binding.

6. Benefits of Becoming an Affiliated Training Partner

Affiliated Training Partners shall become eligible to participate in various skill development initiatives undertaken by TSC, subject to scheme guidelines.

Key benefits include:

- Opportunity to participate in skill development initiatives implemented by TSC under Central Government, State Government, CSR, Industry, International and other programmes, subject to project-specific requirements and scheme guidelines.
- Eligibility for implementation of TSC-supported projects
- Access to industry-recognized training curriculum and Qualification Packs
- Candidate assessment and certification through TSC
- Industry networking and capacity-building opportunities
- Enhanced institutional credibility through TSC affiliation

Special Benefits for Textile Mills

Training Centres established within textile mills can transform from being a cost centre into a value-generating resource through:

- Participation in Government-funded skilling programmes
- Partial or full financial support for training delivery under eligible schemes
- Availing benefit of trainee stipends under select Government schemes
- Development of an industry-ready workforce aligned with operational requirements

7. Terms & Conditions

- 1. Governing Framework:** Training Partner Affiliation and empanelment shall be governed by the prevailing TSC Affiliation Norms, policies, guidelines, and any subsequent amendments issued by TSC from time to time.
- 2. Validity of Empanelment:** Empanelment shall ordinarily remain valid for a period of one (1) year from the date of approval, subject to satisfactory performance, continued compliance with TSC requirements, and periodic review.
- 3. Affiliation Fee:** Applicants shall be required to pay the applicable Training Partner Affiliation Fee, renewal charges, and any other fees, if applicable, as prescribed by TSC from time to time.
- 4. No Guarantee of Project Allocation:** Empanelment does not confer any right to receive projects, training targets, funding, or work orders. Allocation of projects shall be based on project-specific requirements, funding availability, technical capability, infrastructure readiness, geographic presence, trainer availability, past performance, and compliance history of TP.

5. **Non-Exclusive Empanelment:** The empanelment shall be non-exclusive. TSC reserves the right to empanel one or more Training Partners for the same or different projects.
6. **Conflict of Interest:** Applicants shall disclose any actual, potential, or perceived conflict of interest that may influence or appear to influence the empanelment process. TSC reserves the right to reject any application where such conflict is identified.
7. **Integrity and Ethical Conduct:** Applicants shall maintain the highest standards of integrity, transparency, and ethical conduct throughout the empanelment process. Any attempt to influence the evaluation process, provide misleading information, offer inducements, or engage in fraudulent, corrupt, or unethical practices shall result in immediate rejection of the application and may lead to suspension, blacklisting, or any other action deemed appropriate by TSC.
8. **Confidentiality and Data Protection:** Training Partners shall maintain strict confidentiality of all information relating to candidates, projects, assessments, Government schemes, and TSC operations. Such information shall not be disclosed to any third party without the prior written consent of TSC, except where disclosure is required under applicable law. Training Partners shall also comply with all applicable data protection and privacy laws and ensure secure handling of candidate and project-related data on any portal or platform prescribed by TSC.
9. **Monitoring and Performance Review:** TSC shall continuously monitor the performance of empanelled Training Partners based on, but not limited to:
 - Quality of training delivery;
 - Candidate enrolment, certification, and outcomes;
 - Compliance with TSC guidelines and project requirements;
 - Timely submission of reports and documentation;
 - Placement and apprenticeship performance, where applicable;
 - Audit, inspection, and monitoring observations.

TSC may issue corrective actions, suspend, or remove any Training Partner from the empanelled list in the event of persistent non-compliance or unsatisfactory performance.
10. **Suspension and Termination:** TSC reserves the right to suspend, cancel, withdraw, or terminate the affiliation and/or empanelment of a Training Partner at any stage in the event of:
 - Submission of false, misleading, or fabricated information;
 - Violation of TSC Affiliation Norms, policies, or project guidelines;
 - Poor or unsatisfactory performance;
 - Non-compliance with statutory or regulatory requirements;
 - Financial irregularities or misuse of funds;
 - Fraud, corruption, unethical conduct, or any act detrimental to the interests or reputation of TSC.

Except in cases involving fraud, corruption, or other serious violations, TSC shall

ordinarily provide the Training Partner with an opportunity to respond before taking such action.

- 11. Amendment of RFP:** TSC reserves the right to amend, modify, extend, cancel, or withdraw this RFP or any part thereof at any stage without assigning any reason. Any amendment or clarification issued by TSC shall form an integral part of this RFP.
- 12. Dispute Resolution and Jurisdiction:** This RFP shall be governed by the laws of India. Any dispute arising out of or in connection with this empanelment process shall be subject to the exclusive jurisdiction of the competent courts at **New Delhi**.
- 13. Reservation of Rights:** TSC reserves the right to seek additional information or documents, verify the information furnished by applicants, conduct inspections or due diligence, and accept or reject any or all applications without incurring any liability or obligation to assign reasons for its decision.
