3) Whether having competency and tool to conduct On line assessment tool is mandatory for affiliation?

Yes, availability of on line assessment platform is a pre qualifier before Desktop Evaluation. Assessment Agency (AA) has to submit the proof of presence of online platform like Screen shot, Contract from software vendor etc.

4) Whether experience in Textile Sector is mandatory in Point ii of Evaluation Matrix?

No experience is not mandatory, if the AA has no experience in Textile Sector the score will be marked “0” in Experience in sector field

5) What is meant by Geographic presence in Point vi of Evaluation Matrix?

Geographic presence captures the physical presence of Assessment Agency in various states/ UT. The following proofs will be required to prove - Geo tagged Photo graphs of office main view, rent deed etc.

**Note: As per NSDC SOP, Minimum presence in 3 different States/ UT is mandatory**

6) What is meant by Subject Matter Experts (SME's) on Payroll?

SME's refers to Experienced Textile Professionals preferably with ITI/Diploma/Degree in Textile Engg/Technology/Processing/Manufacturing/ Handloom and at least five years of experience in one or more of the following sub sectors - Spinning, Weaving, Knitting, Processing, Technical Textiles & Handloom & Khadi.

The following Proofs will be required along with CV to ascertain eligibility of SME— Educational Certificates, Experience Certificates, Appointment letter or Salary Slip.

The Eligibility for SME is given in Page no 3 of Guidelines document

7) What is meant by Assessor on Payroll?

Assessor on payroll means Textile Assessor in the following sub sectors - Spinning, Weaving, Knitting, Processing, Technical Textiles & Handloom & Khadi who is on the payroll of the organization Applying for affiliation as AA

The following Proofs will be required along with CV – Educational Certificates, Experience Certificates, Appointment letter or Salary Slip, Assessor certificate issued by Textile Sector Skill Council (If applicable)
